The Department of Communication at the Shiv Nadar University would like to announce that admissions to their program, MFA in Film & Television are now open for the academic year 2017-18.

The Master's Degree in Fine Art (Film & Television) programme offers courses in direction, cinematography, editing, sound design, screenwriting, multi-camera video production and documentary film-making among others. The fully residential 2-year programme is designed to accommodate those with the passion and drive to pursue a career in cinema and television as creators and story-tellers.

**Eligibility:** A candidate should have a 3-year or longer undergraduate degree in any discipline from a recognized university or institution to be eligible to apply. The ideal candidate should demonstrate aptitude and an orientation towards arts and creativity. A portfolio of creative works will strengthen the applicant's candidature. The portfolio could comprise images, music and audio recordings, video clips, original written work, etc. Along with the completed application form, each candidate is required to submit a roughly 500-word Statement of Purpose.

**Portfolio:** The applicant should list the submissions that make up the portfolio in the application form, which they will be required to present during the interview. Please upload a listing of portfolio you would be bringing for interview in the application upload section. The allowed formats of portfolio are

- Images in JPEG format.
- Audio Recordings in MP3 format
- Video Clips in MP4 format
- Documents in DOC or PDF formats

1. The first step in the two-stage process is an online submission of the application form with all the required enclosures. Last date for submission of the online form is **28th June 2017**.
2. Based on the application and the **Statement of Purpose**, a shortlist will be drawn up by the department. Shortlisted applicants will be informed accordingly and invited for an interview from **10<sup>th</sup> to 12<sup>th</sup> July 2017** at the Shiv Nadar University campus.

Candidates will be required to bring all the original documents and portfolio listed in their application.

You will be required to pay a non-refundable application fee of Rs. 1,200 (One Thousand Two Hundred Only) by credit/debit card or Demand Draft drawn in favor of **Shiv Nadar University** payable at **NOIDA**.

- Tuition Fee Waiver is for 4 semesters only.
- All charges are payable at the beginning of the Academic Year as per schedule announced separately
- Summer Semester
  - Registration as per schedule and courses advised by Dean Graduate Studies
  - Tuition Fee for Summer Semester is charged at ₹6,000 per credit
- Mess and Laundry Charges: In addition to the above, the use of mess and laundry services from the University authorized resident vendor is mandatory for all resident students irrespective of the degree program they are pursuing. We collect ₹21,500 per semester for mess and ₹ 2,250 per semester for laundry, which is pass through to the vendors. These charges are collected by the University at the beginning of every semester and paid to the vendor. These charges may vary from year to year based on inflation and the decisions of the relevant student body and Dean-Student Welfare, and will be communicated by Dean-Student Welfare at the beginning of each academic year.
- Security deposit is refunded on Graduation after deduction of any recoveries.
