Admission to M.Sc. (Economics)

The Department of Economics at the Shiv Nadar University would like to announce that admissions into the M.Sc. (Economics) programme are now open for the academic year 2017-18.

The M.Sc. (Economics) is a two year (four semesters) program. The students undergo fairly rigorous training that prepares them equally well for jobs in the government, the private sector, NGOs as well as for admission into PhD programs if they so wish to do. The department has a vibrant faculty with varied research interests offering the masters students the option of studying in a wide range of exciting sub-disciplines in economics. Please see the graduate prospectus of the department for more details.

Eligibility:

Students who have or will have a bachelor's degree (in any discipline) with at least 55% in aggregate by September 2017 may apply. Prior economics training is not required.

The eligibility criteria mentioned above are minimum standards and applications not meeting the same will be summarily rejected. Short-listed candidates will be required to demonstrate their knowledge through an on-site written test to be held on 21st May 2017. Selections will be based on performance in the written examination. **Please note that not all candidates meeting the minimum eligibility criteria may be shortlisted.**

Admission Process:

1. The first step in the admission process is a written test held across four cities in India: Delhi-NCR, Kolkata, Bengaluru and Mumbai. Candidates will be informed about the venue of the test at least a week before the exam date. The written test will be held on **21st May, 2017**. Applications for admission are to be made online. **The last day for applying to the program is 14nd May, 2017.** You will be required to pay a non-refundable application fees

of Rs. 1,200 (One Thousand Two Hundred Only) by credit/debit card or Demand Draft drawn in favor of **Shiv Nadar University** payable at **NOIDA**. Admit Card for the written examination will be sent out to the candidates by email. **Do note there is no need to send anything by post for Masters if you are paying online.**

2. The test will have 50 multiple choice questions. There will be 5 questions that test comprehension and analytical abilities. The remaining questions will be from Economics (Undergraduate level) and Basic Mathematics. Detailed syllabus for the admission test and information about the grading and ranking scheme is available in the graduate prospectus.

Fees and Assistantships:

All interested applicant shall apply online from the link given below. Please follow the instructions carefully.

- Fill all the mandatory fields
- Online upload of following document is required
 - Passport size color photograph
 - Current CV
 - All Mark sheets/Degree Certificates (10th Standard onwards)
- After the payment option you will be given the choice for Entrance Examination centers, please rank the in order of preference.
- After online submission, print the completed form and send by speed post to the University at the address given below with following document
 - Completed form
 - Demand Draft for application fee (If online fee payment mode is not used)

Please note that the application is not deemed complete until we receive all the necessary prescribed documents and application fees.
