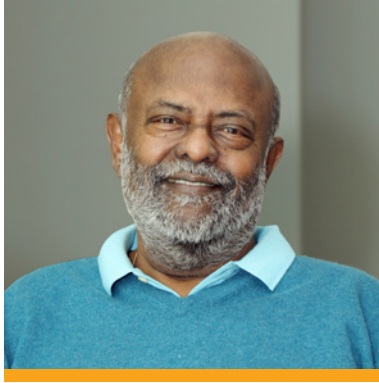
Shiv Nadar University

1. DEPARTMENT OF STUDENT AFFAIRS

Shiv Nadar IoE being a fully residential campus offers more than just academics. Life beyond the classroom is an integral part of your educational journey and student experience at the University.

1.2 Igniting Student Entrepreneurship

At the core of Shiv Nadar IoE's innovation ecosystem is Shiv Nadar AIC (Atal Incubation Centre)—a not-for-profit incubator driving entrepreneurial excellence on campus. Supported by national innovation bodies including the Atal Innovation Mission (NITI Aayog), Startup India Seed Fund Scheme (SISFS), Department of Science and Technology (DST), and the Ministry of Electronics and IT (MeitY), the Centre empowers the next generation of changemakers.

With a strong focus on student-led innovation, Shiv Nadar AIC provides comprehensive support—including expert mentoring, prototyping facilities, market access, and funding opportunities—through various government and institutional schemes. It runs multiple flagship initiatives such as Startup Cradle, an annual capacity-building program for Shiv Nadar University students; Venture Challenge, a structured incubation platform for accelerating, and growing ventures across various geographies; and InvestoPitch, an investor connect forum for high-potential ventures. The incubator has also facilitated ₹1.5 crore+ in seed and pre-seed funding support under schemes like SISFS and MeitY's GENESIS.

To date, Shiv Nadar AIC has supported over **164 startups** across diverse sectors including DeepTech, HealthTech, EdTech, Cleantech, and Mobility. More than 20 student ventures have been nurtured and funded through Startup Cradle, reflecting the growing spirit of innovation among the university's student community. One recent example is TRACER, a student-led startup developing an AI-powered road condition monitoring solution. Out of 3 student-led ventures that applied for funding under the GENESIS Entrepreneurship-in-Residence (EIR) program, TRACER was selected and funded—exemplifying the university's deep-tech potential being applied to real-world infrastructure challenges.

Beyond structured programs, Shiv Nadar AIC plays a central role in nurturing the entrepreneurship ecosystem within the university. In collaboration with student-led clubs and academic departments, AIC supports a range of innovation-focused initiatives—hackathons, demo days, ideation challenges, and speaker series with startup founders and industry leaders.

With a network of 40+ expert mentors and 30+ strategic partners, Shiv Nadar AIC continues to embed entrepreneurship into the academic fabric of the university—equipping students not just with ideas, but the tools to turn them into impactful ventures to shape India's innovation future.



1.3 Breeze

Breeze is the University's annual techno-cultural fest, bringing together students from across the country to participate in and enjoy a variety of performances and events. The event provides students from our University and other institutions a platform to showcase their creativity and enjoy a wide array of activities and performances. 1.4 Housing and Accommodation

The student hostels are state-of-the-art, and gender segregated. They are designed to cater to individual requirements of personal space, while also incorporating a culture of shared living. Each room is designed as a comfortable independent unit with basic in-built utilities. The hostel facilities are spread over 18 buildings across the campus. Wardens are assigned to ensure smooth functioning of various facets of hygiene, safety, security and miscellaneous needs of the student community.

Each hostel has certain common facilities as below:

Study Rooms:

Each hostel has designated study rooms, where students can study, do their academic projects etc. These rooms are air conditioned, are under CCTV surveillance and have access control. All study rooms have LAN ports on the desk that offer data at high speed to be utilized on a shared basis by all residents. These 24x7 study rooms are meant for academic work and the users are strongly advised to maintain the decorum of the place.

Recreation Rooms:

Common rooms offer recreational facilities such as TV, table tennis and yoga/other activities. Students can use these facilities in their leisure time.

Laundry Services:

The hostels have an efficient laundry system. While an authorized vendor provides on-campus laundry services, there are domestic washing machines in hostels for use by students for their personal needs, restricted to only small / sensitive clothes that cannot be given to laundry. Washing of blankets, shoes, jackets, foot mats etc. in the washing machines is not allowed. The washing machines may only be used from 0600 hours to 2300 hours on all seven days of the week.

Room Configuration and Facilities:

The rooms in various buildings are of different configuration - single accommodation with attached or common washrooms, twin accommodation with common washrooms and studio type accommodation. Rooms are allotted to students as per university policy. The rooms and washrooms are well-fitted and are designed to maintain essential hygiene standards. The common areas in all the hostels are Wi-Fi enabled. The common areas of hostels are cleaned daily, while the individual hostel rooms are cleaned twice a week by the house keeping staff as per the schedule displayed close to the lift in every hostel.

Pantries:

Each hostel is provided with a pantry on the ground floor, equipped with microwave oven, egg boilers, induction cook tops, toaster and instant geysers for hot drinking water. Purified water is available on all floors at all hours for the convenience of the students. The pantries may be used only for preparation of light snacks and are not meant to be an alternative to the dining halls. Cooking is not permitted in the hostels. Residents are to ensure that the pantries are used and maintained in a neat and hygienic manner. Misuse of pantry facilities may result in debarment of further access.



1.5 Health & Wellness

The campus is equipped with a Health & Wellness Centre that offers comprehensive primary medical and mental health support. This includes a primary care facility and an Outpatient Department (OPD), providing round-the-clock care for medical emergencies and pre-hospital treatment.

The Centre features observation and emergency rooms, fully equipped and staffed by qualified paramedics. A General Physician (GP), nursing staff, and ambulance services are available 24/7. In case of emergencies or cases requiring advanced care, both an Advanced Life Support (ALS) ambulance and a Patient Transport Ambulance (PTA) are on standby to transfer patients to tertiary care facilities.

Students can book OPD appointments online via the Habit Health App (available on Playstore/Appstore) or visit the clinic directly for walk-in consultations. Pathology sample collection is also available at the Centre on a paid basis.

A 24/7 pharmacy is located on campus to meet all OPD and general medical needs. It stocks over-the counter medicines, prescription medications (available on order), and a range of health and hygiene products.

Adjusting to life away from home can be challenging. The Centre provides mental health support to help students manage stress, anxiety, depression, and other emotional concerns. Two clinical psychologists reside on campus and are available for counselling.

Specialist services include weekly visits from a gynaecologist, and fortnightly physical consultations with an orthopaedist, a dermatologist and online psychiatrist consult. Physiotherapists are available every weekday to assist with pain management and rehabilitation.

Dental services are also offered. Dentists provide free consultations every weekday, and dental procedures can be availed at a nominal cost.

Students are referred to the following super specialty hospitals in case of need:-

1. Kailash Hospital, Greater Noida
2. Yatharth Hospital, Greater Noida
3. Fortis Hospital, Greater Noida



Medical Insurance

We are committed to the overall health and wellbeing of our students. In addition to the health centre on- campus, students are provided medical insurance by Oriental Insurance Company Limited. This covers medical issues that require hospitalization beyond the on-campus services. This is a seamless policy which covers cashless hospital admission and treatment up to ₹ 2.5 lakh. All UG, PG, and PHD students are covered under this policy. Students should reach out to the hostel administration to know more about their policy details or in case of any related query.

The salient features of the health insurance are communicated to the students during orientation as a part of their registration process when they join Shiv Nadar IoE.

Salient features of the Policy are:

- Valid for 12 months, till such time they are enrolled with the university, including while on leave.
- 4000+ hospitals are covered across the country.
- No room capping.
- No waiting periods.
- Ambulance charges up to ₹2000/- per hospitalization.
- Pre-Hospitalization and Post Hospitalization for 30 days & 60 days respectively are covered.



2. SPORTS

Whether you're a seasoned athlete or picking up a sport for the first time — this is your space. The Shiv Nadar IoE Sports Programme, managed by the Department of Physical Education, is built around one idea: that sport makes you better in every area of life.

We have world-class facilities, qualified coaches across 10+ sports, and a calendar packed with competitions, leagues, and events. Dive in, stay active, and make the most of your time here.

2.1 Facilities

Our Indoor Sports Complex (ISC) covers 1,20,000 sq. ft of air-conditioned space. The complex was awarded the NDTV 2017 Award for design architecture. Outdoor facilities are open from 6 AM to 9 PM (under expert coach supervision).

SURGE – The Annual Sports Fest

Surge is Shiv Nadar IoE's flagship inter-university sports festival, held every October/November. Since its launch in 2021, it has grown into one of the biggest collegiate sports events in the country.

UWE – Introduction to Sports (SPO201-2001)

The University-Wide Elective (UWE) in Sports, **Introduction to Sports (SPO201-2001)**, is a flagship initiative of the Department of Physical Education aimed at promoting an active, healthy, and engaging campus culture. Open to students from all undergraduate disciplines, the course provides a beginner-friendly introduction to sport through a balanced combination of theory and practical learning.

Students may choose from a range of sports including badminton, squash, table tennis, tennis, basketball, cricket, football and volleyball, and will be guided by qualified coaches and instructors throughout the semester. Beyond physical activity, the course is designed to help students develop important life skills such as discipline, teamwork, resilience, leadership, and time management, while encouraging participation, wellness, and lifelong engagement with sport.

Fitness Fiesta

Fitness Fiesta is a campus-wide wellness and fitness initiative designed to encourage students to adopt active and healthy lifestyles through fun, engaging, and inclusive activities. Organized by the Department of Physical Education, the initiative promotes awareness about the importance of regular exercise, mental wellness, nutrition, and overall fitness while creating an energetic and participative environment on campus.

Open to students, staff and faculty of all fitness levels, Fitness Fiesta aims to build a culture of health, motivation, and community engagement through fitness and movement.

SNUSL – Shiv Nadar University Sports League

SNUSL is the intermural competitive league, run by the Student Sports Council. Students are divided into four clubs, each with its own identity and fan following:

- Bulls
- Falcons
- Panthers
- Phoenix

Clubs compete across multiple sports throughout the academic year. SNUSL is also where varsity scouts spot talent, so come ready to perform.

Night of Champions – Annual Sports Awards Night

Night of Champions is the University's annual sports awards evening dedicated to celebrating excellence, commitment, and contribution in sports and physical activity. The event recognises outstanding performances by student-athletes, teams, coaches, and members of the university sports community across various categories during the academic year.

Apart from honouring competitive achievements, the evening also celebrates values such as leadership, teamwork, discipline, resilience, and sportsmanship that define the spirit of sport at the University. Bringing together students, faculty, staff, and distinguished guests, Night of Champions serves as a platform to acknowledge sporting excellence and inspire greater participation and engagement in campus sports culture.

Rules & Guidelines

These guidelines keep our facilities safe, fair, and enjoyable for everyone. Please read them carefully.

Access & Participation

- All students have equal access to all sports facilities and activities.
- Disclose any medical conditions to the Sports Department before participating.
- Students must use sport-specific footwear at all times — this protects both you and the courts.

Gear & Equipment

- Bring your own personal sports equipment (racquets, bats, etc.). Equipment may be issued from the sports store subject to availability and on submission of University ID.
- Cricketers and footballers must carry full personal kits, including footwear, towels, caps, and water bottles.
- Proper footwear is mandatory: running shoes, football studs, non-marking shoes for indoor sports, basketball shoes, tennis shoes, cricket shoes and turf boots for the astroturf courts. Metal studs are strictly prohibited on astroturf courts.
- Proper sports attire is mandatory on all courts. Slippers, jeans, and casual wear are not permitted. Students found non-compliant will be asked to leave the court/field.

Conduct & Sportsmanship

- Respect your teammates, opponents, coaches, and officials at all times.
- Adherence to game rules and sportsmanship standards is mandatory.
- Students must wear designated sports apparel during training sessions and official matches.

Facility Rules

- Do NOT play cricket or any other sport on synthetic basketball/tennis courts. Violators will be fined.
- Walking through the cricket field is strictly prohibited. Violators will be fined.
- Handle all equipment and facilities responsibly. Damage caused by negligence is chargeable to the student responsible.

Lockers

- Lockers at the ISC may be allotted on request, subject to availability.
- You are solely responsible for the security and maintenance of your locker contents.
- Losing your locker key will result in a fine.

3. STUDENT SUPPORT SYSTEM

3.1 Family Groups

All first-year undergraduates are assigned to a Family Group, guided by a Family Head selected from the senior batches, to aid in a seamless and friendly transition during the initial phases of settling in. The Family Head guides, supports, and facilitates the student's access to any necessary information, and serves as a friendly and accessible mentor for Freshers on campus. The Family Heads and their activities are guided by the Associate Director and Head of Student Life.

3.2 Department of Student Affairs Helpdesk (DSA Helpdesk)

The DSA Helpdesk serves as a centralized support platform for students, streamlining two key services through a single access point. It allows students to book the Visitor's Hostel room for parents accommodation. Additionally, it functions as a Lost & Found system, enabling students to report missing belongings. Students can conveniently access the DSA Helpdesk through official SNU links.

3.3 Gender Champions

Gender Champions are responsible students who facilitate an enabling environment within the Shiv Nadar Institution of Eminence, where every gender is treated with dignity and respect. They strengthen the understanding and potential of the young students to advocate for gender equality and strive for progress towards gender justice.

3.4 Peer Support Guides

In the bustling world of university life, where academic challenges intertwine with personal growth, we have in place a vital support system known as Peer Support Guides (PSGs). These dedicated volunteers are not merely students; they are the nurturing guardians associated with family heads, entrusted with the task of fostering a sense of belonging and well-being within their designated family groups. At the heart of their mission lies a profound commitment to safeguarding the mental and emotional welfare of every student associated with them. Peer Support Guides report to the Associate Director and Head of Student Life and carry out various engagement activities in consultation with her.

3.5 Online Counselling Services

Shiv Nadar Institution of Eminence has associated with **YourDOST** to provide our students with round the clock access, online and via a dedicated helpline, to qualified providers of emotional and wellness support. Consultations may be on any matter that a member of the student community is facing and are entirely private and confidential. Students have benefitted by accessing YourDost on issues related to stress, career, academics, relationships, self-confidence, and many other personal matters in a language of their choice.

3.6 Campus Buddy (for International Students)

Every international student is assigned a student volunteer as a Campus Buddy. The Campus Buddy assists the international student in settling down and in navigating various aspects of campus life. Campus buddies play a crucial role in fostering a welcoming and inclusive campus environment, and enhancing the overall student experience for international students.

3.7 Student Opportunities Management System (SOMS)

Undergraduate students who meet laid down performance criteria are provided opportunities, from the second year onwards, to work with different departments on campus. SOMS assist in the functioning of the department they are assigned to and gain experiential and applied learning, which helps them develop workplace ethics, leadership qualities, and service attributes. These roles are open to undergraduate students from their second year onwards.

Possible jobs under this policy may include (but are not limited to) extending assistance in laboratory and library management, monitoring projects, conducting surveys and analysing feedback, managing help desks, aiding departments in enabling functions of the University like Admissions, LASC, Career Development Centre, Department of Student Affairs, Administration, Hostels, Sports, and allied activities, etc.

Students doing On Campus Jobs (OCJ's) are paid a stipend for their work, which helps them to imbibe a sense of accountability and responsibility. Students will be paid 100 rupees per hour for OCJ's during the academic sessions, with a maximum limit of 20 hours per week. During vacations, the payment will be 75 rupees per hour, with a maximum limit of 40 hours per week. For students engaged in OCJ's during summer vacations, the hostel fee for that period should be borne by the sponsoring department. For details, please visit

Eligibility:

- OCJs are open to all undergraduate students except first year and certain masters' degree programs (without any Teaching Assistantship and only for jobs specific to post-graduate programs) of Shiv Nadar IoE.
- Students must maintain satisfactory academic progress (CGPA above 6.0) , have a good disciplinary record and adhere to the policies and guidelines set by the University to retain an OCJ position.

Circulars and Application Process:

The OCJ process is exactly like a formal 'recruitment' process in any well-managed company. The positions are formally advertised to the student community. Circulars for OCJ are posted via email from the DSA office, along with an application form and job description. Interested students should submit the application form to apply for the jobs. Candidates are interviewed by the respective departments and are made an offer upon selection.

3.8 Campus Affairs – Hostel Committee

The Student Led Hostel Committee looks after the Hostel Affairs. The Student Council selects a Secretary of Campus Affairs and assigns Senators to be the Heads of the Hostel Committee. These four Senators along with the Secretary of Campus Affairs conduct interviews and select members for the Hostel Committee. The Hostel Committee consists of members, with at least one person from each hostel block having the status of a student and residing in the respective blocks.

Duties of the Hostel Committee

- The heads of the hostel committee report to the Secretary of Campus Affairs regarding the effective discharge of duties by the hostel committee.
- They interface with their respective wardens at least once a fortnight and discuss with them the issues in their respective hostels.
- They represent the general welfare of the students residing in the hostel and assist the council and wardens in maintaining the living standards.
- The committee, in coordination with the maintenance, ensures proper maintenance of the hostel rooms, common room, toilets, and premises.
- They report any unauthorized use or misuse of hostel rooms and bring to notice any untoward incident occurring in the hostel premises to the warden.
- The hostel committee requires to meet at least once a month. These meetings are presided over by the Secretary of Campus Affairs. Once in two months the committee along with Campus Affair Secretary meets the Head Hostel Administration.
- Town halls to address to hostel concerns are conducted periodically, to be organized by the Campus Affairs Secretary along with the hostel committee and attended by member of the Hostel Administration.



4. COMPLAINTS COMMITTEE (UNIVERSITY LEVEL)

4.1 Anti-Ragging Committee

Ragging includes, but is not limited to, actions such as: display of noisy, disorderly conduct, or performing any act which causes or is likely to cause physical or psychological harm or raise apprehension or fear, shame, or embarrassment to a student in any academic institution.

This includes teasing, abusing, playing practical jokes, or causing hurt to students, or asking a student to do any act, or perform something, which a student would not in the ordinary course be willing to do.

UGC Regulations on curbing the menace of ragging in higher educational institutions cover any act of physical or mental abuse (including bullying and exclusion) targeted at another student (Fresher or otherwise) on grounds of colour, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background.

The University gives paramount importance to safety and security of every student and follows a zero tolerance policy towards ragging.

As per the directives of the Hon'ble Supreme Court of India and the University Grants Commission, ragging is a cognizable and punishable offence and is prohibited on or off campus. The University shall act in accordance with the UGC regulations on curbing the menace of ragging in higher educational institutions, 2009, against those found guilty of ragging and/or abetting ragging, actively or passively, or being part of a conspiracy to promote ragging.

All students, enrolled in any UG, Masters or PhD programme are mandatorily required to file an anti-ragging affidavit on the website www.antiragging.in by **30 June every year**, in order to be eligible for enrollment and residence on campus. Uploading any document other than the current year antiragging affidavit on antiragging@snu.edu.in will lead to disciplinary action.

Process for Filing Anti-Ragging Undertaking/Affidavit

- Students may visit the link: <https://antiragging.in/> or https://antiragging.in/affidavit_registration_disclaimer.html or https://antiragging.in/affidavit_university_form.php to complete the online anti-ragging affidavit to be filled in by the student/ parent/ guardian.
- After filling this form online, students will receive a confirmation email on their registered email address with a reference number confirming their submission of the affidavit.
- The confirmation email should be forwarded to **antiragging@snu.edu.in** and a screenshot/ PDF of the confirmation email should also be uploaded at the document upload section on the pre-registration portal.
- Students are subsequently required to upload the confirmation number, or a screenshot of their successful filing of the affidavit, in order to be eligible to apply for accommodation in the hostels.
- Freshers and other students and members of faculty and staff must promptly bring any instance of ragging to the notice of the authorities of the University.

4.2 Anti Ragging Squad (ARS)

In accordance with regulations, Shiv Nadar IoE has constituted an Anti-Ragging Squad. The composition and responsibilities of this squad has representation from various segments of the campus community to maintain vigilance, oversight, and patrolling functions. The squad remains mobile, alert, and active at all times. It does not include any outside representation.

Terms of Reference for ARS:

- The ARS shall take all measures which are necessary to prohibit and prevent ragging in Shiv Nadar IOE and will perform duties as set out in the UGC Regulations.
- Primary role of ARS will be to maintain vigil, oversight, patrolling, and conduct surprise checks in the hostels and other places vulnerable to incidents of ragging.



4.3 Disciplinary Committee

A Student Disciplinary Committee (SDC) has been constituted at Shiv Nadar IoE, which functions under the Department of Student Affairs. The SDC is responsible for handling minor offences and serves as a first-level mechanism to deal with student-related disciplinary cases. Apart from University authorities, the SDC also has one member nominated from the Student Council, usually the Vice President.

Appeal Against a SDC Decision

A student awarded a punishment by the Student Disciplinary Committee shall have the right to file an appeal before the Proctorial Board, in writing, within 10 days from receipt of the order of punishment by the SDC. The appeal may be handwritten or printed but must be signed by the student themselves. The physical copy as well as a copy by email should reach the Proctor (email ID: proctor@snu.edu.in) within the stipulated period.

The Proctor, being the Chairperson of the Proctorial Board (PB), along with two other members of the PB will consider the Appeal after calling for the records from the Student Disciplinary Committee. It will be at the discretion of the Proctor, whether or not to hear the appellant student in person. The Proctor should ideally decide the matter within 15 days from the date of receipt of the Appeal. In case an extension is required, the Proctor should promulgate a speaking order, stipulating the number of additional days required to come to a decision on the Appeal. This should be an exception, and in any case, all endeavour should be made to come to a reasoned decision within no more than 30 days.

- *The PB, while considering the appeal may entertain fresh evidence, provided it was not presented before the SDC, when the matter was first heard.*
- *The PB may uphold the decision of the SDC, moderate the penalty or grant more severe punishment.*
- *The outcome of the Appeal is conveyed as a report to the Dean of Students and also to the Vice-Chancellor.*
- *Once decided, the decision of the PB on the Appeal shall be binding and there shall be no further appeal against the decision..*

4.4 Proctorial Board

The Proctor of Shiv Nadar IoE Deemed to be University shall be the Chairperson of the Proctorial Board (PB) and will be responsible for handling major infractions and acts of indiscipline on campus. The PB will serve as the second-level mechanism to deal with student-related disciplinary cases.

Appeal Against a PB decision

A student awarded a punishment by the Proctorial Board shall have the right to file an appeal before the Vice-Chancellor in writing within 10 days from receipt of the order of punishment. The hard copy of the appeal in writing, signed by the student should be submitted to the office of the Vice-Chancellor and a soft copy of the appeal should also be mailed to the office of the Vice-Chancellor on email ID vc@snu.edu. in within the stipulated period.

The Vice-Chancellor will consider the appeal after calling for the records from the Proctorial Board. It will be at the discretion of the Vice-Chancellor to accord a hearing to the appellant student. The Vice-Chancellor should normally decide the appeal within 15 days from the date of receipt of appeal. If an extension is required to decide the appeal, a speaking order for such extension of time should be passed. However, all endeavours shall be made to decide the Appeal within no more than 30 days.

- The Vice-Chancellor, while considering the appeal may entertain fresh evidence, provided it was not presented before the PB, when the matter was first heard.
- The Vice-Chancellor may uphold the decision of the PB, moderate the penalty or direct more severe punishment. The outcome of the Appeal will be conveyed to the PB and to the Dean of Students, who shall thereafter convey it to the appellant student.
- There shall be no further appeal to the decision of the Vice-Chancellor. The decision of the Vice-Chancellor shall be final.

4.5 Procedure of Complaint/ Enquiry and Punishment

- Chief sources of complaints include-Hostel, Security, Health Centre, Food and Amenities vendors, Faculty, Staff, Parents and Students.
- The Hostel/ Security/ Faculty/ Staff/ Parents, and Students should report to Member Secretary of the Disciplinary Committee in writing through e-mail followed by Incident Report within 24 hours and without losing any time from the time of the occurrence/ information received.

4.6 Appeal for Suspension of Disciplinary Award on Special Consideration

Any student awarded punishment, other than Termination or Suspension from the University, may appeal for having the punishment suspended for up to seven days for special family occasions. This is a privilege that is allowed only once in an academic year.

- a) Punishment by Student Disciplinary Committee: Appeal addressed to **chair.dc@snu.edu.in**.
- b) Punishment by Proctorial Board: Appeal addressed to **proctor@snu.edu.in**.



4.7 Internal Complaints Committee

Shiv Nadar IoE is committed to providing a place of work and study, free of gender bias and sexual harassment, intimidation or exploitation. It is expected that all students, faculty and staff will treat one another and visitors with dignity and respect. All members of the Shiv Nadar IoE community, including those who are in temporary or short-term positions and employed with third party vendors, are expected to contribute towards ensuring that the workplace is free of gender and sexual harassment.

The Internal Complaints Committee (ICC) also called the 'Gender Committee', at Shiv Nadar IoE, is responsible for matters related to the Policy for the Prevention of Sexual Harassment (PoSH) on campus.

The responsibility of promoting gender sensitivity and taking action in cases of sexual harassment has been vested with ICC. Reports of sexual harassment are taken seriously and dealt with promptly by the ICC in accordance with the provisions of the University Grants Commission (Prevention, Prohibition and Redressal of Sexual Harassment of women employees and students in higher educational institutions) Regulations, 2015. The University has recently re-constituted the ICC w.e.f. July 2026, as per the above mentioned UGC Regulations, and the Government of India notification no. 14 of 2013, regarding 'The sexual harassment of women at workplace (Prevention, Prohibition and Redressal) Act 2013'. The regulatory framework of ICC is guided by UGC requirements as well as Shiv Nadar IoE's Gender Policy.

All students are required to attend a mandatory sensitization session conducted by the ICC at Shiv Nadar IoE. Club functionaries and members of Student Council have to take these sessions before they assume elected positions. The orientation seeks to educate participants regarding sexual consent, promote understanding of an environment of cooperation and dialogue among members of the University, while also making students aware of their rights and duties. The ICC and the University strongly believe in the importance of fostering gender equity, and maintaining a campus free of sexual harassment to ensure that our students have the best possible environment to pursue their goals.

Any aggrieved person (employees, students, third party vendors) may file a formal written complaint against any incident of sexual harassment by email, to the Chairperson of the ICC at: gendercommittee@snu.edu.in

4.8 Students Grievance Redressal Cell (SGRC)

In consonance with the University Grants Commission (Redressal of Grievances of Students) Regulations, 2023, the Shiv Nadar IoE has constituted the SGRC. The objective is to provide opportunities for redressal of certain grievances of students already enrolled in Shiv Nadar IoE, as well as those seeking admission to Shiv Nadar IoE, and a mechanism thereto. The students may register their concerns related to grievances in the **SGRC portal link** deployed in the students digii campus app or sgrc@snu.edu.in. The same will be examined and addressed in the SGRC.

4.9 Financial Assistance for Students

The University is committed to ensuring that financial constraints do not prevent deserving students from pursuing their education. To support students facing genuine financial hardship, the University provides financial assistance based on demonstrated financial need. The policy is only applicable to UG and PG students.

Students whose parents have experienced a sudden and unforeseen change in their financial circumstances, affecting their ability to finance their ward's education, may apply for financial assistance. Applications must be submitted in the prescribed format along with all required supporting documents.

Each application is assessed on its individual merits through a fair, transparent, and comprehensive review process. The evaluation considers the applicant's financial circumstances, academic performance, and the supporting documentation provided.

Financial assistance may be granted in the form of partial or full tuition fee waivers, subject to the recommendations of the designated committee and the approval of the Competent Authority. The extent and duration of assistance will depend on the applicant's financial need, eligibility, and the University's policies.

Students receiving financial assistance are expected to:

- Maintain satisfactory academic performance as prescribed by the University.
- Adhere to the University's Code of Conduct and all applicable rules and regulations.
- Promptly inform the University of any significant improvement in their financial circumstances.
- Submit any additional documents or information requested during the review process.

Financial assistance is awarded for a specific academic period and does not automatically continue in subsequent years. Students seeking continued assistance must submit a fresh application and demonstrate ongoing financial need in accordance with the University's policies.

The University remains committed to fostering an inclusive learning environment by supporting students whose education may be adversely affected by unforeseen financial challenges, ensuring that deserving students have the opportunity to successfully pursue and complete their academic journey.

5. OTHER SERVICES

5.1 Student ID Card

Student ID card is an accountable document that earns rights and privileges, besides establishing identity. Loss of identity card is a serious offence as it may lead to a student's identity being misused. Shiv Nadar IoE has an online process for applying for a duplicate identity card. The tab for applying is active on SNU Links. Students must submit their physical ID cards to Admin office at the time of graduating/finally leaving the University in order to obtain clearance.

Process for applying Duplicate ID Card

1. Student can log into the ID card management system application with their NetID and submit a request for a Duplicate ID Card.
2. Request will come to DSA for Approval.
3. Once DSA approves, the request will be routed to Finance Department. The student needs to pay Rs 500/- for duplicate ID card to the finance team who will update the paid status in the application. The approval by DSA is not automatic and repeat offenders may face the disciplinary action.
4. The request will reach the administration team who will prepare the new ID card after payment is confirmed by finance. When the card is ready for issue, admin will update status on the app and the student will get an email notification for collecting ID card from admin department.

5. All students must deposit their University ID card with the Department of Student Affairs through their Hostel Wardens at the time of taking final clearance/leaving the University on Graduation. Failure to do so will attract a penalty (fine) of Rs 500.



5.2 Food on Campus

Dining Halls

The University campus is home to students from 28 States & UTs, and the cuisine available on the campus reflects this diversity. Catering to the cultural and food preferences of students, the three large dining Halls (DH 1, 2 & 3) provide healthy and varied fare. The dining areas adhere to the highest standards of hygiene consciousness and are well furnished and fully equipped.

The students' food committee under Secretary of Food Affairs participates in finalizing menu with vendors and conducts audit of all food operations on the campus.

The dining halls provide vegetarian and non-vegetarian breakfast, lunch, evening snacks, and dinner as per the published menu, as well as certain a-la-carte options. We accommodate requests for specific diets, such as Jain and Vegan, as well as cater to individuals with specific allergies. A midnight meal is served till 2:00 AM every day for those who burn the midnight oil in various academic and extracurricular pursuits.

5.3 Courier Desk

Students can collect their online ordered package from the courier desk/racks in D Block.

5.4 Transport

University-chartered buses are available for students on the weekends on paid basis. The bus shuttles between Noida GIP (Great India Place) and the University. The Student Transport Committee manages the service, and the trips are planned on the recommendation of the committee.

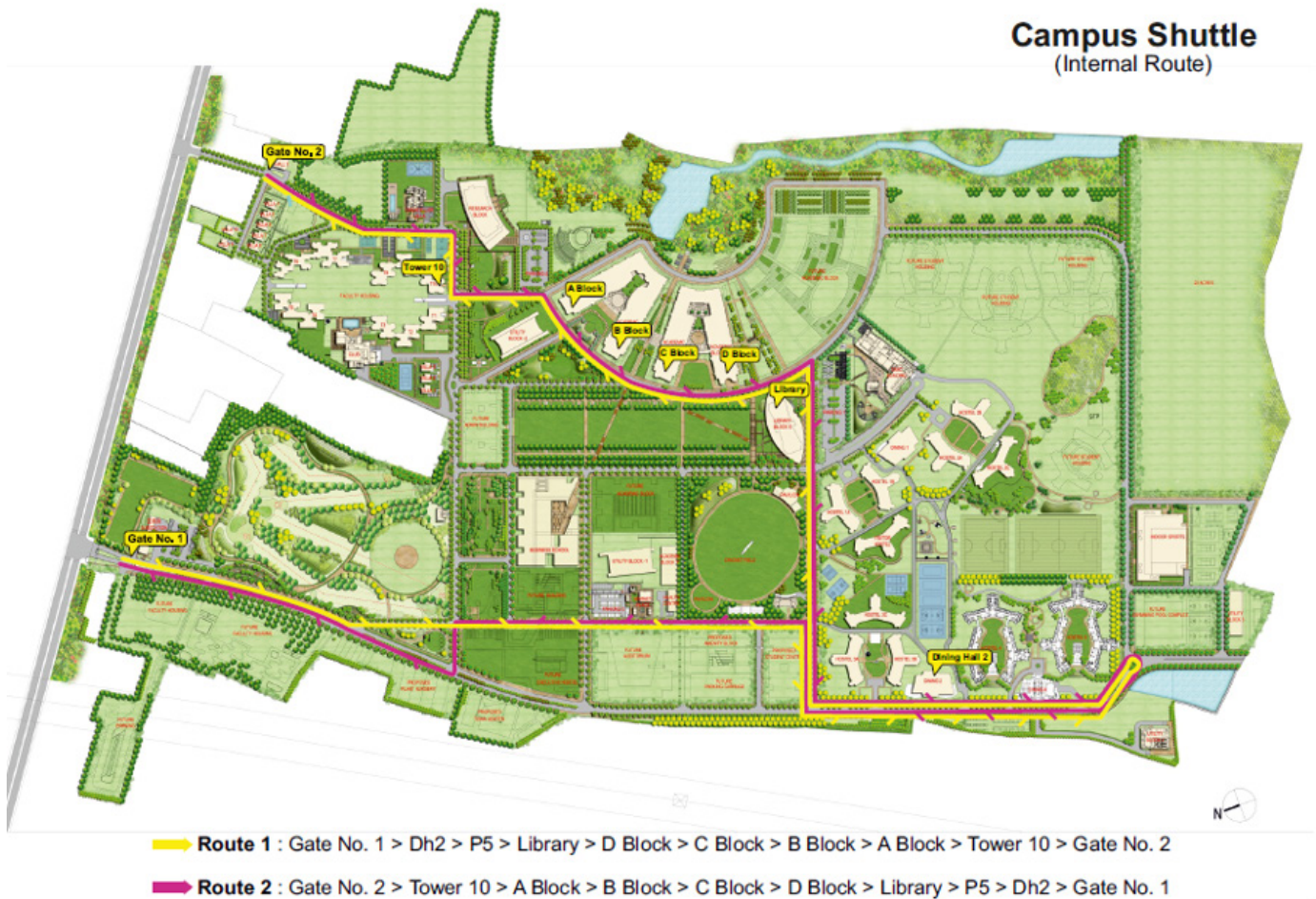

A regular campus shuttle service runs every 20 minutes along routes as shown.

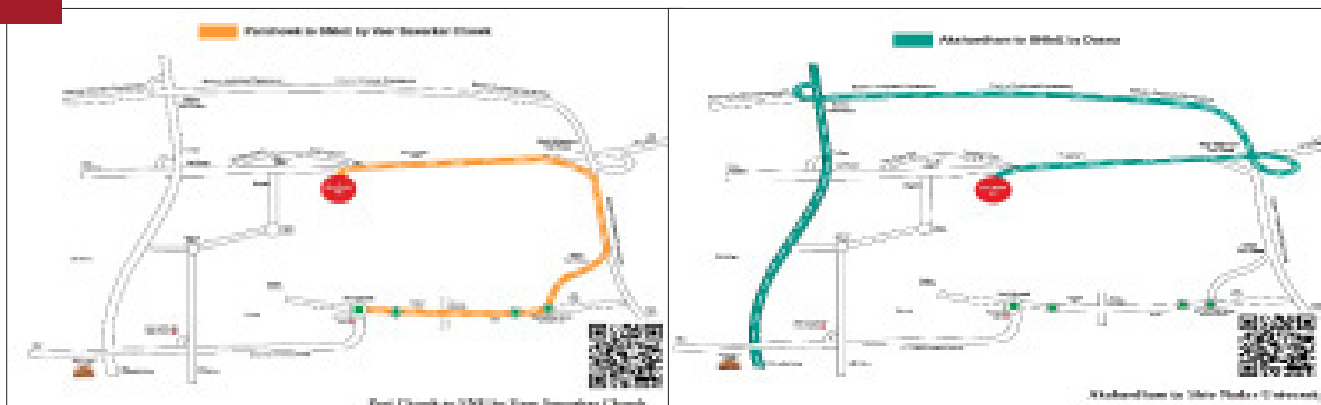


Campus Shuttle (Internal Route)

5.5 Stay at Visitor's Hostel for Parents of Shiv Nadar IoE students

Visitors Hostel is available for stay of parents of students, subject to availability and booking as per laid down process, given below. In the normal course, the duration of stay should not exceed three days, no more than once a month.

- Students must book the VH (Visitor Hostel) through the DSA Helpdesk link accessible via SNU links, providing all required details. VH booking requests will only be considered for students' parents and accompanying close relatives. **Requests submitted via email will not be entertained/accepted.**
- Rates for rooms may be ascertained from the DSA help desk. Meals are available on a chargeable basis and the payment should be made by guests at VH office.
- The Admin Department will confirm bookings as per availability. The confirmation should be shown to the authorities at VH office as and when requested. The same will be checked at visitor's hostel by the staff on duty. It is advisable that the students inform D Block security about arrival details of the parents to make the process smoother. The security can facilitate pickup from Gate No.1 if required.
- Visitors Hostel booking should be made at least three working days prior to requirement. (Mon-Fri).
- Driver (if any) accompanying the visitors, can also be accommodated on a paid basis.
- Students are NOT allowed to enter Visitor's Hostel and parents will not be permitted inside student hostels. VH Reception Desk provides them with Guest Wi-Fi access.
- Parents would need to make their own travel arrangements to reach Shiv Nadar IOE. Self- driven cars need to be parked at Parking 1.

6. CODE OF CONDUCT

The Student Code of Conduct applies to any student enrolled in any credit course at Shiv Nadar IoE, including exchange students.

6.1 Freedom with Responsibility

Shiv Nadar IoE, Delhi-NCR, trusts students to do what they think is best for them and for the University, and believes in giving them the freedom and information to support their decisions. In turn, the University expects students to demonstrate responsibility and self-discipline in their conduct.

6.2 Celebrating Diversity

Students come from diverse backgrounds, beliefs, religions, cultures, perspectives, gender, and experiences. Inclusivity plays an extremely important role in the success of our community. Discrimination based on physical appearance, gender, sex, caste, creed, colour, religion, region, or culture is prohibited and if reported will be dealt under the provisions made in University Code of Conduct.

6.3 Respect for Rule of Law and University Policies

- Students should not indulge in any activity that causes any obstruction to teaching, learning, research, administration, and other bonafide activities in the University.
- No student should indulge in any activity, on or offline, that hurts or targets any other students, faculty or staff personally.
- University's rules and policies are to be followed strictly. All these policies are easily accessible on the intranet, SNU Links. <https://snulinks.snu.edu.in/application/student-policy> and \ “#ST 212 Policy for Dealing with violation of the Student Code of Conduct” in SNU Links.
- Any student-organized activity on campus, whether indoors or outdoors, needs permission from the Dean of Students at least three working days in advance. If any activity relating to academics requires use of venues other than labs or classrooms, the admin helpdesk will need to be informed in advance, to make necessary arrangements.

6.4 Zero Tolerance Offences:

Shiv Nadar IoE observes zero tolerance for offences as is detailed below:-

- No person who is a student of a University shall commit ragging, which includes but is not limited to teasing, embarrassing, humiliating, assaulting and/or using criminal force or criminal intimidation, wrongfully restraining, or confining or causing hurt and /or taking introduction. In dealing with the acts of ragging, reference will be made to the definition of ragging as stipulated in Vishwa Jagriti Matter (1999) and the UGC Regulation on Curbing the Menace of Ragging in Higher Educational Institutions, 2019.
- No persons shall cause sexual harassment at place of work, study place or extended study place and every person is expected not to commit offences as is detailed in the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 and University Grants Commission (Prevention, Prohibition, and Redressal of Sexual Harassment of Women Employees and Students in Higher Educational Institutions) Regulation 2015.
- Procuring and/or Possessing and/or Consumption and/or Aiding and/or Selling of any narcotic drug or psychotropic substances.
- Causing injury to the faculty, staff, administrative members of the University on or off-campus.

6.5 Hostel Expulsion

The students awarded the decision of 'Hostel Expulsion' by the internal disciplinary committees will be asked to vacate the hostel with immediate effect and will be considered to be expelled from the hostel, for the entire duration of the mentioned semester. Further, the hostel fees will have to be paid in full by them for the entire mentioned semester; or, if they had paid the hostel fees, the hostel fees would not be refunded by the university. The students who are awarded the decision of Hostel Expulsion, once they re-join and resume the academic session and residential stay in their respective places, will remain under academic and disciplinary probation for the duration of their remaining stay at the university. Any subsequent offence would lead to serious punishment that could include termination from the university.

Penalties: Penalties for offences classified under Zero Tolerance would follow the UGC Guidelines/ Notifications, including the judgment of the Supreme Court on the subject and violations thereof. These may also lead to suspension and expulsion from University and legal action against the perpetrators, for which the University will file an FIR, if desired. The University may also file a legal complaint if deemed necessary.

6.6 Suspension

Any student found guilty of serious or persistent violation of guidelines shall be temporarily barred from attending classes, not allowed to stay inside hostels, barred from giving examinations, or participating in any university activities. This is a form of punishment for violating regulations or engaging in any kind of misconduct/indisciplined behaviour. The length of the suspension can vary based on the gravity of the offence and the rules of the institution. The purpose of suspension is to serve as a deterrent and allow the student to reflect on their actions and make positive changes. Most suspensions are temporary, giving students time to improve their conduct and reintegrate into the university community after the period awarded has passed. For more information, please refer to the Policy for dealing with violation of the Student Code of Conduct.

6.7 Termination

Any student found guilty of persistent violation of guidelines, or of serious offences may be expelled or terminated from the Shiv Nadar IoE. This would constitute permanent severance of the student's relationship with the Shiv Nadar IoE. For more information, please refer to the policy for dealing with violation of the Student Code of Conduct.



7. HOSTEL RULES

These rules apply to ALL residents who are allotted rooms in the student hostels. No student will be allowed to stay in the hostel unless enrolled in courses. The first point of contact for all hotel related issues is the Hostel Warden. Shiv Nadar IoE is a fully residential campus and all student enrolled at the University except PhD scholars have to stay on the campus for the duration of their respective programs.

Section A

A.1 Occupancy of Hostel Rooms

Twin sharing/ single occupancy rooms are available in the hostels, which shall be allotted to students by the Hostel Administration. Single rooms will not be allotted to UG first year students. Residents are required to carry out the check- in/ check-out formalities personally on the prescribed format available with the warden when occupying or vacating their rooms. Wardens will assist in the process. The process of allocation of hostel accommodation shall be as decided by the University and the type of room allotted will be subject to availability.

A.2 Duration of Different Programs and Stay at the Hostel

- Undergraduate Programs -B.Tech., B.Sc., B.A., minimum of 6 full semesters to maximum of 12 full semesters, ideally completed in 8 full semesters.
- Master's Programs - MTech., M.Sc., M.A., four full semesters.
- Ph.D. Program, eight to ten full semesters (as per the residency requirements of the particular program). Accommodation will not be provided after completion of five years of the program.
 1. Any student who needs to stay beyond the duration of their program will have to seek permission from the Dean of Students for extension, which shall be considered subject to the availability of rooms.
 2. All students have to pay their hostel fees as directed by the Finance Department. The Living Expenses which include Hostel, Mess and Laundry are paid yearly/semester wise depending on the policy. The academic year runs from August to May with a Winter Break during December.
 3. There is a Summer Semester during June and July for which charges are over and above the living expenses done for the academic year. There is a process in place for securing a bed during summer semester. Student should apply to the Dean Students office at least two weeks in advance for the same with the approval from the concerned department.
 4. Students are permitted to reside in a hostel on the condition that they rigorously adhere to the hostel rules and university code of conduct. Ignorance of rules will not be accepted as an excuse for violation.
 5. The university administration may deny accommodation to any resident/student who violates the hostel rules or whose presence is likely to disturb the peace and tranquillity of hostels. Violation of hostel rules will make the student liable to disciplinary action which may include permanent expulsion from the hostel.

Section B

B.1 General Rules and Regulations

1. Students are required to stay in their allotted rooms only. Changing of the allotted rooms is not allowed unless approval is obtained from the Deputy Dean of Students, Head Hostel Administration in writing. Any non-adherence to the guideline will lead to appropriate disciplinary action.
2. Restricted Hostel Hours (RHH) will apply for first-year UG students. Physical/ biometric attendance will be taken at their hostel's reception upto 12:00 AM. They are expected to return to their hostels accordingly. Any violation will result in disciplinary action or suspension of gate pass by the Hostel Administration.
3. Students are not allowed to leave the campus before 06:00 AM and after 09:00 PM on weekdays. Students who leave campus in the day are required to return to the campus premises before 09:00 PM on all days, unless they have an approved night pass.
4. Students are not allowed to keep speakers in the hostel / University or play loud music on hostel / campus. Speakers of any size or kind found with any student / scholar will be confiscated and not returned. Earphones must be used for music, movies, games, or online classes in rooms or common areas so as not to disturb others.
5. Students must not create noise or disturbance on campus or in the hostels. Quiet Hours will be enforced from 11PM to 6 AM every night. Violators will be liable for disciplinary action.
6. Students are not permitted to visit staff or faculty members residing in campus housing. Wards of the University staff/ faculty will be permitted to visit their homes on campus only on weekends/ festivals with due authorisation from Deputy Dean of Students, Head Hostel Administration.
7. Possession or consumption of alcohol, cigarettes, and substances of abuse is strictly prohibited on campus. Aiding, abetting, consumption, and possession of any such material and activities are liable to attract strict disciplinary action and may lead to suspension / termination from the University.
8. Students must not misuse sports courts or fields, or trespass into unauthorised areas. Defaulters may face disciplinary action.
9. During a regular semester, the university administration can ask any Student / Scholar to change room / hostel under circumstances which are in line with the University functioning and deemed necessary by the authorities.
10. Students are required to always carry their identity card and produce it on demand to any authorized person. Students will not be allowed to move in or out of campus without a physical ID card.
11. Students who are not mapped to any hostel will be required to make an entry in the register at the reception and their ID will be deposited at the reception for the duration of their stay.
12. Tailgating at the turnstile (hostel / main gate) will be viewed seriously and may attract disciplinary action.

13. Students are required to cooperate fully with the authorities to ensure security and shall not argue or misbehave with security personnel.

14. The warden or any authorized member can inspect any student's room at any time, in presence of at least one Shiv Nadar IoE student.

15. Students are not allowed to put up notices or posters in the hostel without the warden's permission.

16. Students are expected to ensure cleanliness of their rooms and to help maintain the general upkeep of the hostel premises.

17. Electrical Appliance Usage Policy in Hostel Rooms The electrical wiring and fittings in hostel rooms are not designed to support heavy electrical loads. Use of unauthorized electrical appliances poses a risk of fire and endangers the safety of the campus community. Therefore, to ensure safety and prevent any hazards, the use of the following electrical appliances is strictly prohibited:

- Refrigerator
- Air Cooler
- Induction Cooktop
- Appliances with heating elements (e.g., Room Heaters, Electric Blankets, Heating Pads)
- Pedestal Fans
- Immersion Rods

Permitted Appliances (Below 500 Watts Only):

- Table fan 12inches or less
- Hair Dryer
- Trimmer
- Electric Iron
- Electric Kettle (strictly for medical use only)

Note: The electric kettle is allowed only for medical purposes. If it is found being used for cooking or any other purpose, it will be confiscated immediately.



Policy on Unauthorized Appliances:

- Any electrical equipment not provided by the hostel or not listed above, if required for medical or special needs, must have prior written approval from the Head of Hostel Administration.
- Unauthorized items found in the rooms will be confiscated and not returned.
- Repeat violations may result in additional penalties as deemed appropriate by the Hostel Administration.

This policy is in place to ensure the safety and wellbeing of all residents, and your cooperation is expected.

18. The items confiscated at the hostel, gate or anywhere on the campus will not be returned.

19. Mess utensils are not supposed to be taken out of the dining halls.

20. Any celebrations such as birthday celebrations/any parties are not allowed in hostel premises. Please use any location outside the hostel premises for the same and be mindful to clear up any litter.

21. Cooking is not allowed inside the hostel rooms / premises, except in the hostel pantries. Possession of cookware other than a pan is not permitted.

22. Pets are not allowed inside the hostel. Students are not permitted to feed any animals on campus, including dogs. Students found feeding dogs or encouraging their entry into hostels/ dining halls/food court/academic spaces will be liable for a fine and disciplinary action.

23. Students are responsible for their belongings. They have been provided with dedicated lockable rooms and storage spaces in the room. They are required to always keep their belongings under lock and key. The University is not responsible for the theft of any personal belongings. The university authority will not be responsible for any unattended belongings in or outside the hostel premises or common areas. Avoid bringing expensive items / jewellery / cash to the campus.

24. All hostel rules apply uniformly to all residents. Ph.D. scholars, as senior residents, are expected to be role models. For room allocation, Ph.D. scholars must use their University Student Roll numbers when registering on HMS, even if they have dual/employee IDs. Hostel rules are outlined in detail in the Policy Document.



B.2 Action against Latecomers

Undergraduate students must adhere to the rules for campus entry and exit. Students who leave campus must return before 9:00 PM on all days, except in cases where permission has been taken for late entry. Students coming late will have their details recorded at the main gate by the University Security, which will be shared the next day with the Department of Student Affairs. In the first instance late comers will receive a warning in writing and gate pass suspension for a week. Repeat offenders will have their gate pass suspended for a longer duration and their parents will be intimated, in addition to facing further disciplinary action/fine as the case may be.

B.3 Exiting the Campus

1. UG students cannot leave campus without permission, which is to be applied for online using the Digii campus app. The app has separate modules for day out and night out. Day out does not require approval, but night out needs parental approval for UG and RM students. PG, MBA, and Ph.D. students do not need parental approval for night out movement. All students/scholars must enter their particulars in the hostel register at the reception when going on a night out and close it upon return.

2. Students who are unable to return on the pre-decided date should extend their gate pass by following the prescribed process available on the DigiiCampus well before 8:30 pm and inform their respective wardens at least 3 hours in advance.

3. The Digii campus process will be followed even for university events like competitions or sports. Proper protocol must be followed, and permits are a privilege, not a right. Students leaving the hostel without permission shall be deemed missing, and parents, guardians, or police may be informed by the Office of DSA.

4. Entry to the university campus is regulated. Students must cooperate with university staff and present their physical IDs when asked. Compliance with security regulations, including maintaining certain records, is mandatory. The Digii campus Exit/Entry system is integrated with turnstiles and biometrics. Students under disciplinary action or otherwise, may have their biometric blocked upon written instructions from the DSA.

B.4 On First Arrival (Every Year)

1. All students must provide their medical information regarding allergies, vaccinations, ailments, and special medical needs to the DSA office with a copy to their hostel warden for emergency care.

2. Upon check-in, students must thoroughly inspect their room and its inventory.

3. In case of damage during check-in, students must email the warden and obtain acknowledgment of their complaint for proof. Without this proof, they are responsible for penalties or fines upon leaving the hostel.

4. Any damages or losses will be noted during check out and a commensurate fine will be imposed.

5. Students must also complete the Info Form provided by the warden during check-in.

B.5 Vacation Period

1. Students must vacate their rooms and take all belongings with them in the summer break(May - July). A cloakroom managed by the student council may be provided. Any student willing to avail this facility should follow the process and protocols mentioned in an advisory given by the Student Council. The University will not be responsible for any loss or damage to the articles/baggage left behind.
2. To avail the hostel accommodation for research/academic/internship or any other official work during vacations (December-January / May-August), students need permission from the Dean of Students, approved by faculty sponsors/advisor and department heads. They must fill out forms at the DSA office and pay applicable fees according to university policies. Students with low CGPA or disciplinary record will not be permitted to stay back on campus.

B.6 Visitors at the Hostel

Entry of the visitors in hostel will be restricted up to the designated areas in hostel reception lobby. The visitors cannot stay beyond 5:00 PM on campus unless otherwise approved by the Dean of Students. Only parents whose information was registered with the university at the time of admission will be permitted to remain on campus until 9 p.m., with prior notification to the respective warden. Any student found to have visitor/s in their room or beyond the designated area shall be liable to disciplinary action to the extent of hostel expulsion.

B.7 Hostel Inventory and Loss of/Damage to Hostel/University Property

1. Students must carefully check hostel room inventory during check-in and handover the rooms in the same condition during check out. They're responsible for movable items like mattresses, curtain rods, lights, fans, locks, etc., during the regular semester.
2. In case of intentional/ unintentional damage to any portion of the hostel buildings, furniture, equipment, or other University property, the loss shall be recovered from the person/s identified as the cause of such damage. However, if the persons responsible for the damage cannot be identified, the cost of repairing the damage will be assessed and distributed equally amongst all the inmates of that particular floor / hostel or group of inmates/students of that wing of the hostel, found responsible for the damage and as deemed fit by the authorities.

B.8 Use of Personal Vehicles

1. Students may use their personal bicycles for movement around the campus. These bicycles are the responsibility of the students and are to be parked in an orderly manner in the designated bicycle parking spaces. Students should not park their bicycles in such a way that blocks access to common passages or inconveniences others in any way. A fine of Rs. 50 per instance may be imposed on owners of bicycles found wrongly parked. Students are required to lock and secure their bicycles to prevent their unauthorised use by others.
2. UG students are not permitted to bring/use any two or four-wheelers or any other form of motorized transport on campus. Self-driven vehicles may be permitted on campus in exceptional case after approval by Dean of Students. The parking duration and location on campus will be specified in the approved email.

3. PG/Ph.D. students may bring their personal vehicles for the purpose of moving in and out of the campus, but not for use inside the campus. Such students must seek specific prior permission from the Dean of Students for bringing personal vehicles to the campus, providing proof of ownership of the vehicle, valid driving licence, insurance, and any other relevant documents asked for. The vehicles will remain the responsibility of the students and Shiv Nadar IoE will not be responsible for their safety. Besides incurring disciplinary consequences, any misuse of private vehicles, or rash driving, may result in the vehicle being impounded and the student may be banned from bringing it to campus.

4. Students are not permitted to park any motorized vehicles in or around the hostel or academic blocks, or elsewhere. Vehicles of those PG and PhD students, who have been granted permission to keep them on campus, may only be parked in the designated parking areas, notified by DSA from time to time. Vehicles found parked elsewhere are liable to be impounded and will attract a fine of Rs. 500 in the first instance. Repeat offenders will be liable for disciplinary consequences, besides the permission to keep the vehicle being withdrawn.

5. Bicycles found to be lying unused/ abandoned at various spaces on campus for a prolonged period will be collected by the administration and kept at a suitable location. Unclaimed bicycles will be disposed of as scrap, after giving reasonable notice of 30 days for prospective claimants to retrieve them.

- It is highly recommended that all your devices support Wi-Fi 6 standards & please note the device compatibility below Wi-Fi 5 standards may face problem in connecting to the Campus network.
- IoT devices (Alexa, Echo, Google Home, Bixby, Speakers, etc) that cannot authenticate 802.1x standard, will not be able to connect to the University network.

For a more stable connectivity with less latency, you may use wired connectivity (where feasible). Please ensure you carry a Cat6 patch cable to utilize the same.

Email Services

Email services are provided to all students. Students should use only the official University email address for all communication with the University. Users need to abide by and comply with the University's policies on the acceptable use of electronic services.

10.UNDERGRADUATE DEGREE REQUIREMENTS

The paragraphs below provide a brief overview of the degree requirements and academic policies. The details for the UG programmes are available in the relevant UG Handbook. Please note that different undergraduate handbooks are applicable to students depending on the year of admission of their cohort. The details for each Master's and PhD programs are available at the respective department's webpages. The academic policies can be accessed under "Student Policy" on SNU links.

To earn an undergraduate degree (major) at the Shiv Nadar IoE, a student must complete the credit requirements as applicable for the opted major. Students must meet the major credits requirements and the University-level requirements in the Core Common Curriculum (CCC) and University-Wide Electives (UWE) categories.

Students Admitted in the Academic Year 2024-25 or Earlier

The total credits for each major, including CCC and UWE, are at least 150 but may be higher. (For instance, all B.Tech. programs require at least 160 credits).

A total of 42 credits in CCC and UWE courses must be earned by the student, with a minimum of 18 credits in each of the CCC and UWE categories. The remaining six credits are in the floating category and can be earned from the Major Elective, UWE, and CCC categories.

Students Admitted in the Academic Year 2025-26 or Later

A student must earn a total of 160-163 40 credits from CCC and UWE courses, with a minimum of 16 credits from each category. The remaining eight credits are in the floating category and can be earned from the UWE and CCC categories. Further, for the Class of 2029 and onwards, a student must complete credit requirements ranging from 160 to 163 to graduate across all undergraduate programs.

The total credits to be earned by a student in a program shall range from 160-163 credits. Of which 120 credits are to be completed from their major courses and the rest 40 credits are to be completed for the buckets of CCC courses (16 credits) and UWE courses (16 credits) and 8 credits are floater credits, that may be used for Major Electives, CCC courses or UWE courses. The credits for UWE courses and the floater credits maybe used to earn a minor or a interdisciplinary specialisation.

Finally, any student to graduate they must have a final CGPA of at least 5.00 out of 10.00. The repercussions of failing to maintain 5 CGPA is to be placed on academic probation and if the CGPA becomes 4 by the end of second semester or subsequently then the student gets discontinued from their program.

Further details on this shall be found in the Policy on Academic Standards.

Every programme has an Undergraduate (UG) Advisor. The UG Advisor is the primary point of contact for any advice on academic matters. In some programs, this role is overseen by the Program Chair.

The Undergraduate Handbook provides a quick reference for students on academic matters that govern all the UG programs at the University. The detailed policies can be accessed under 'Student Policy' on the SNU links.



Credits:

At the University, one credit is equivalent to 30 notional learning hours. Notional learning hours include learning inside and outside the classroom, excluding self-study time. One credit requires a student to be engaged in one hour per week of classroom teaching and one hour per week of outside classroom learning, or two hours per week of practical classes, or three hours per week of experiential learning over a semester.

The recommended number of credits per semester to meet the degree requirements in a timebound manner at the University is 18-22 credits. Students can enrol for a maximum of 25/26 credits per semester depending on their year of admission.



Grades

At the completion of the credit course, every student who has registered for that course shall be awarded a letter grade by the faculty. Each letter grade has an associated number of grade points:

To successfully complete a course, a student needs to get at least the minimum passing grade of D in that course. The Cumulative Grade Point Average (CGPA) is the weighted grade point average of all credit courses completed by the student up to that point. An illustration, specific to cohorts AY 2024-25 and before, is given below:

$$\text{CGPA} = (5 \times 10 + 4 \times 7 + 4 \times 4 + 3 \times 6) / (5 + 4 + 4 + 3) = 112/16 = 7.00 \text{ out of } 10.00.$$

An undergraduate student who fails to maintain a CGPA of at least 5.00 will be placed on Academic Probation.

If the CGPA of a student fall below 4.00 at any time, from the end of the second semester onwards, the student will receive a letter of discontinuation from the University and will not be allowed to continue in the program. The student will be deregistered from the University.

Duration:

Given the way the programs are structured, an ideal student is expected to graduate within four years or eight full semesters. However, the maximum permissible time to complete all the degree requirements is within six years of their registration at the University.

'Full semester' refers to the Spring (January to May) and Monsoon (August to December) semesters.





Master's Degree Requirements

To earn a Master's degree in a specific programme from the University, a student must complete the requirements as prescribed by the programme. The requirements may consist of a mix of major core and major elective courses. Several programmes may also require completion of a project/thesis/internships for degree completion. The total credit requirements for graduation would vary depending on the programme of study. The department shall prescribe the number of credits required from major core and major elective courses.

Major core courses are to be taken by all students registered in the programme. The major elective courses are choice-based and are offered by the department for students to choose from to fulfil their credit requirements. Detailed course information and degree requirements shall be available from the individual department/school. The program's Postgraduate (PG) Advisor or Program Chair shall be available to provide more information and guide students.



Doctoral Programs:

The University's Ph.D. program regulations define the academic requirements, rules and regulations for obtaining a Doctoral degree. Every student is required to complete the coursework as per their programme requirements. The academic regulation for the doctoral program, along with other pertinent information is available on the website.

Attendance Policy for UG

1. Attendance is mandatory for all courses.
2. Attendance for a class is marked by the faculty member (course instructor).
3. All undergraduate students at the University are expected to be present for all of the scheduled classes. For whatever reason (personal or official), a shortfall of no more than 25% is permitted on each course.
4. The Office of the Dean of Academics monitors fulfilment of the minimum attendance requirement.
5. The UG Handbook provides the detailed attendance requirements. The policy on student attendance requirements can be accessed on SNU Links.

11.OPPORTUNITIES FOR UNDERGRADUATE RESEARCH (OUR)

The OUR program at the University gives students hands-on experience in conducting research and independent work under faculty supervision. Through the program, students develop a foundational understanding of how research is conducted in their disciplines, learn about possible resources and the way to utilize them as well as how to interpret research outcomes. This program has paved the way for students to learn by discovery, has enabled greater student-faculty interaction and expanded the level of research activity on campus; while also helping to identify and train potential candidates for the University's graduate programs.

12. STUDENT MOBILITY AND EXCHANGE PROGRAM

The Student Mobility and Exchange Program at Shiv Nadar Institution of Eminence is designed to provide students with international academic exposure and meaningful cultural immersion. Managed by the International Office, the program facilitates semester-long and year-long study opportunities at partner universities across the globe. We have multiple opportunities of online and offline master classes by professors from our partner universities. Students also get to meet them at career fairs organised by our international office.

The Office in collaboration with Dean of Academics Office and DSA Office oversees all aspects of the exchange process, including academic planning, logistics and student support, ensuring a seamless and enriching international learning experience.

Outbound Mobility Program

The outbound mobility program enables students to study specialized courses at leading international partner universities. Engagement periods range from one semester to a full academic year, with flexible options designed to align with students' academic pathways and career aspirations.

The various outbound opportunities are:

- Semester exchange programs
- Summer Schools
- Full-year academic engagements
- Flexible interdisciplinary learning opportunities
- Research Internships
- Participation in Conferences and Seminars worldwide
- Masterclasses by university professors at partner universities

Prior to departure, selected students participate in comprehensive pre-departure orientation sessions covering:

- Academic expectations
- Cultural awareness and adaptation
- Visa and travel requirements
- Housing and logistical arrangements

During the exchange period, students receive continued support from both the host university's international office and the Shiv Nadar IoE International Office. Academic progress is regularly monitored to ensure students remain aligned with their degree requirements and learning goals.

The program is curated to provide transformative global experiences that deepen students' understanding of diverse cultures, perspectives, and educational systems.

Please note: Students with poor academic performance or disciplinary records are not considered for the program.

Note: Hostel fees are a part of Annual Fees. If a student is registered for a semester and does not have a year/semester drop, they will be charged the full Tuition and Hostel Fee whether the student stays or not, as we are a fully residential campus. The same applies to the final-year students pursuing an internship next semester. The university will not be refunding them the hostel fees as per policy. Mess and Laundry fees are exempted for certain cases after an approval from the Dean of Research and Partnerships for Masters/PhD students and Dean of Students for UG students.

Mess & Laundry Fees Waiver

Mess & laundry fees are waived for students who participate in off-campus internships or external projects as part of their academic curriculum and are selected for Outbound Mobility or exchange programmes with partner universities in their final year at Shiv Nadar IoE. The waiver is valid for the duration of the programme or as specified by the Dean of Students. Hostel fees are not waived except in cases where a student will be away on exchange for the entire academic year. In such cases, once approved by the Dean of students, no hostel accommodation will be allotted to the student.

For waiver of mess and laundry fees student must apply on the prescribed form available in DSA office to the Department at least 15 days in advance of the program. Once recommended by the HOD, approval will be waiver accorded by Dean of Students and forwarded to Finance Department, with intimation to Dean of Academics and the Career Department.

Once approved, the waiver of food and laundry charges will be applied to the student's account for the duration of the programme. Students are required to promptly notify the DSA office of any changes or modifications to the programme to ensure that the waiver is adjusted accordingly.

All students moving off the campus for internships must inform the Careers Development Centre (CDC) team. cdc@snu.edu.in in giving full details with dates, in order to be considered for waiver of mess and laundry fees. Students in their final year who have completed their credits and wish to leave campus and be exempted from paying mess and laundry fees, must obtain approval from Dean of Academics, prior to applying for the fee waiver as above.

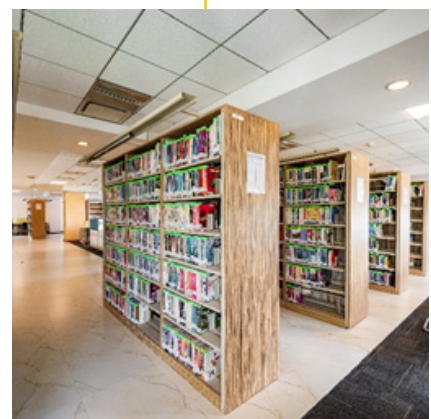
13. LIBRARY ONLINE PUBLIC ACCESS CATALOGUE

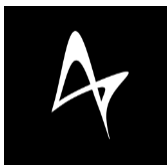

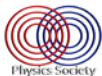

First-year students are not permitted to participate in OCJ during their first semester.

How to book a room in the Visitor's Hostel for my Parents?

Students must book the VH (Visitor Hostel) through the DSA Helpdesk link accessible via SNU links, providing all required details. VH booking requests will only be considered for students' parents and accompanying close relatives. Requests submitted via email will not be entertained/ accepted.

What transportation options are available for students?

The university-chartered buses are available for students on the weekends on paid basis. The bus shuttles between a Noida ,Great India Place Mall and the University. The Campus Affairs Committee manages the service, and the trips are planned on the recommendation of the committee.

What health services are provided on campus?

The University offers a wide range of Health services which provides physical and mental health support through a primary health care set-up and an OPD. Pre-hospital management care is done on campus and all medical emergencies are provided on a 24x7 basis. The Health Centre has a team of four doctors (general physicians), two resident physiotherapists, two clinical psychological counsellors, and dentist, besides nursing staff and ambulances. A visiting Orthopedic, Gynecologist, Dermatologist may be consulted at the clinic on their scheduled day of the week or fortnight. Deployed medical staff on campus has well defined OPD slots can be booked by logging on <https://www.healthyhcl.in/snioe/#book> or by walk-in to the clinic.

Gender Champions are student leaders who promote gender equality and respect within the university community, reporting to the Associate Director and Head of Student Life. First year students can also apply to become the Gender Champions. Forms will be out in the month of August for Freshers.

Who are peer support guides?

Peer Support Guides are students dedicated to providing support and guidance to their peers, especially those facing emotional challenges, to ensure a safe and inclusive university environment with utmost confidentiality. They are usually senior students.

Can I start a new club on campus?

Yes, you can start a new club on campus by submitting a club proposal outlining your club's purpose, activities, and membership criteria to the Dean of Students and Associate Director, Student Engagements office for approval. New clubs are usually approved if there is adequate demand for it.

Are there opportunities for international students to get involved in campus activities?

Absolutely! We encourage international students to participate in campus activities, clubs, and events to enrich their college experience and connect with fellow students. You can also explore cultural exchange programs and international student organizations.

Are there opportunities for students to showcase their talents through performances or exhibitions?

Yes, students can showcase their talents at various fests and events organized by the University. Students can also participate in events at other universities after due approval by DSA.

How can I stay updated on campus news, events, and announcements?

You can stay updated on campus news, events, and announcements through University newsletter, Digi screens placed on the campus, following official social media accounts, checking the university website regularly, and joining student communication platforms or apps.

What clubs and organizations can I join on campus, and how do I get involved?

You can join a variety of clubs and organizations based on your interests including academic clubs, cultural clubs, recreational clubs, and societies, as well as volunteer groups. You can get involved by attending club fairs, joining club meetings, participating in club activities, and taking on leadership roles.

What types of hostel rooms does the University offer?

The University provides Twin and Single rooms in both AC and Non-AC categories, with common toilets. Room allocation depends on the student's enrolled course and availability.

Are there hostel accommodations with attached bathrooms?

Yes, we offer accommodation with both attached and common bathrooms, depending on the course enrolled for and availability.

What facilities are available to students in the hostel?

Hostel facilities include 24/7 security, 24/7 power backup, 24/7 internet connectivity, Laundry services, Mess facilities, Sports facilities, First aid and medical facilities

How many meals are provided daily?

Four meals are provided: Breakfast, Lunch, Evening Snacks, and Dinner. In addition, there is a midnight mess provided from 2300hrs to 0200hrs.

What is the quality of food like?

The university contracts mess facilities based on Food Safety and Standards Authority of India parameters. Currently, Sodexo provides these services. The menu is created in consultation with student representatives and experienced staff. We maintain high food quality and adhere to strict hygiene standards.

What items are provided to students in the hostel?

Each student is provided with a bed with mattress, study table, chair, cupboard, AC / Non-AC room with common facilities.

Is there medical insurance for students?

Yes, the University provides medical insurance for all students upto an amount of Rs 2.5 lakhs (hospitalization only).

Is Shiv Nadar IoE a ragging-free zone?

Yes, Shiv Nadar IoE maintains a strict zero-tolerance policy against ragging in hostels and on campus, in compliance with Supreme Court, Government of India, UGC, AICTE, and State Government regulations.

Can students keep personal vehicles on campus?

No, personal vehicles are not allowed. Students are encouraged to use bicycles to keep the campus pollution-free.

Is there a laundry facility in the hostel?

Yes, laundry facilities are available in the hostel for a nominal charge, offering both wet cleaning and ironing services.

How do I report anything not working or needing repair in my room?

Write a mail, addressed to callbob@snu.edu.in with the cc to warden, to report anything not working or needing repair in the hostel room. For sample mail, please refer to Pg 44 in the student handbook.

What are the rules for leaving campus for the day or overnight?

UG students cannot leave campus without explicit permission, which can be applied online using the Digii campus app. The app has separate modules for day out and night out. Day out does not require approval, but night out needs parental approval for UG and RM students. PG, MBA, and Ph.D. students do not need parental approval for night out movement. All students/scholars must enter their details in the register at reception when going on a night out and close it upon return.

What sports are offered in the University?

Coaching for the following sports are available: Athletics (Track & Field), Badminton, Basketball, Cricket, Squash, Football, Volleyball, Table Tennis, Tennis, Yoga.

Other than this, there are student-led clubs for horse riding, chess, cycling and mixed martial arts.

What are the timings for sporting facilities?

Timings for ISC (Indoor Sports Complex): 6-9am and 5-9pm. ISC is closed on university holidays. Timings for outdoor courts of badminton, tennis and basketball are 6am-11pm.

Is there a membership charge for gym or any other sport?

Currently, there is no fee for any of the facilities.

Will sports equipment be provided?

Yes, equipment may be issued from the sports store depending on availability. However, it is recommended that you get your own equipment. Racquets, footwear and sports clothing should be brought by students for their own use.

Do the teams participate in external and inter university tournaments?

There are university teams for all the coached sports and chess which regularly go for inter university tournaments. Surge, The Sports Fest of Shiv Nadar IoE organized in Oct/Nov each year is one of the biggest events as various universities come to our university to compete in a multitude of sports.

Are there any internal/recreational events?

Yes, two of the highly anticipated events are the SNU Sports League and the Inter Hostel Cluster Sports League. In addition the sports department organizes running and cycling events from time to time.

There are various other recreational and competitive events happening year round as well. Please keep an eye on your inbox for communication regarding the various sporting events.

Are there leadership opportunities with sports?

Yes, there are multiple opportunities which include being a part of the Sports Committee, Manager of a club in SNU Sports League, Surge etc.
