The Chairperson requested Dr. Ambar Habib, Dean UGS to make a proposal in the next Academic Council meeting and get it approved by the AC.

Item No. 5 To discuss Credit Transfer policy of the University

Dr. Amber Habib, Dean UG Studies briefed the members about the credit transfer policy of the University. The policy envisaged the admission procedure, eligibility criteria, number of seats for admission through lateral entry in the second year of the undergraduate course at SNU and eligibility for credit transfer. The members opined that policy should include provision of entertaining lateral admission requests only from the institutions accredited by the highest level of accreditation agencies in India and abroad.
