For single-room occupation, the students may apply to the dean of students and upon availability of such rooms, students may be allotted single room AC/Non AC upon payment of the applicable rate for such rooms. Master's students would be allowed to avail the hostel fee waiver of INR 25,500.00 on the rack rate of such rooms if allotted. For instance:

Notes:

- Teaching Assistantship is available to select meritorious students in MA - English and MSc- Economics/Chemistry program only. It will be given as defined in the program brochure. MFA may selectively offer up to 2 TA Ship with INR 12000.00 per month for a maximum of 20 months during the program duration.
- Waivers for tuition and Hostel fee are for 2 years only. Beyond year 2, the student must pay the tuition/Hostel fee in full. The Department reserves the right to reduce or not give the waiver, based on the academic credentials of the applicant.
- Continuation of financial assistance is subject to satisfactory performance evaluated continuously, and

compliance with all University regulations. The student is required to maintain a minimum CGPA of 7.00.

4. Failure to maintain a CGPA of 7.00 at the end of the second semester will result in loss of tuition fee waiver for the rest of the program (i.e. 3rd and 4th Semesters). Tuition fee waiver once lost can never be restored.
5. All charges are payable at the beginning of the Semester as per schedule announced separately. Semester fees shall be equal to half of the annual fees.
6. Mess and Laundry Charges: In addition to the above, the use of mess and laundry services from the University authorized resident vendor is mandatory for all resident students irrespective of the degree program they are pursuing. We collect the charges for these @ ₹ 27,500 per semester for mess and @ ₹ 2,500 per semester for laundry.
7. **Hostel, Mess and Laundry Fee/Charges:** Subject to revision every year by up to 8%. The decisions will be communicated at the beginning of each academic year.
8. **One time admission charges will be inclusive of access to Sports facilities, career development services and convocation fee.**
9. **University Health Services fees: An annual fee of 10,000 INR will be charged.**

10. Refund Policy:
