Item No. 3 Quality initiatives undertaken by the University (2021-22)

The Director IQAC apprised the members of the IQAC regarding the quality initiatives undertaken during the Year 2021-22.

Suggestions on the policies and automation were put forth by the members and special invitees. Some of these are noted below:

- a) Capping of loan to 30% of the project budget was suggested by Dr. Sanjeev Galande, Dean SoNS on the Research grant policy updates
- b) At the time of separation from the University, a faculty needs to clear all pending dues including settling all projects/ consultancy undertaken during the tenure at SNU. A mechanism to ensure this needs to put in place by HR
- c) The Chairperson suggested that all ongoing projects should be reviewed periodically. Dean Research informed that this has been provisioned in the new policy.
- d) To create awareness regarding all policies and processes, the Chairperson suggested devising a suitable mechanism. The Registrar informed the members that he is working on a Mandatory disclosure and dissemination of relevant information to the SNU community.

Item No. 4 Reconstitution of the IQAC

Director IQAC informed the members that according to the mandate of NAAC, the IQAC requires to be reconstituted after every two years. With the pandemic and the governance changes happening at the University, the reconstitution was put on hold. The Chairperson then directed that reconstitution of the IQAC be undertaken as per NAAC guidelines.
