Notes:

1. Medical Insurance is compulsory for all Ph.D. Students. Premium for Medical Insurance may vary based on bulk rates negotiated by the University with service provider. Detailed information can be had from SNU HR Office.
2. Please note that the Hostel Fees may increase yearly by 8% in subsequent years.
3. Waivers
 - a. Waivers for tuition and hostel fee is for 8 semesters only. Beyond 8th semester, the student has to pay the hostel charges and tuition fee in full.
 - b. The Department reserves the right to reduce the waiver based on the academic credentials of the applicant.
 - c. A Ph.D. student may retain, lose or restore her tuition fee waiver on yearly basis. From second year onwards, the retention, loss or restoration of tuition fee waiver will be based on the following conditions

- i. At the end of 2nd Semester, CGPA ≥ 7.00 : The student will retain tuition fee waiver for 2nd year (i.e. 3rd and 4th semesters)
 - ii. At the end of 2nd Semester, CGPA < 7.00 : The student will lose tuition fee waiver for 2nd year (i.e. 3rd and 4th semesters). Student has to pay fee differential as per SNU Fee Policy
 - iii. Retention, loss or restoration of scholarship from 3rd year onwards: It will be based on student maintaining satisfactory academic performance every year, as defined by Dean, Graduate Studies
4. Continuation of financial assistance is subject to satisfactory performance evaluated continuously, and compliance with all University regulations. The student is required to maintain a minimum CGPA of 7.00.
5. The Fellowship is assured for a maximum of 48 months only and cannot be combined with any other fellowship or stipend.
6. All charges are payable at the beginning of the Academic Year as per schedule announced separately.
7. The use of laundry services from the University authorized vendor is mandatory for all students. Advances for Laundry are ₹ 2,100 per semester. These charges are subject to change and shall be communicated by Dean-Student Welfare.
8. Mess charges are on actuals and shall be paid directly to the vendor by the student.
9. Security deposit is refunded on Graduation after deduction of any recoveries.

Notes:

1. Part time PhD program does not have any residential requirement. Hostel facility is not available for Part Time students
2. Candidates can use the Guest House for overnight stay on the charges applicable.
3. Candidates can also use current dining halls for food, by paying at the counter.
4. There is no financial assistance available from SNU for this program.
5. For 5th Year and beyond the fee charges will continue at ₹ 1,25,000 per year

Part-Time Ph. D. Program Regulations

Qualified candidates unable to attend SNU on a Full-Time basis may choose to pursue part-time Ph.D. program. SNU does not provide fellowship/assistantship to such candidates. The candidate can be self-sponsored or sponsored by other organizations.

Eligibility criteria for Part-Time Ph.D. candidate is same as that of full-time candidate. Additional criteria (Geographic limitations, minimum experience levels etc.) shall be imposed by the department. A part-time Ph.D. external (sponsored) candidate has to provide a no-objection certificate from his/her employer before admission.

Residence Requirement

Part-Time external candidates have to fulfill residence requirement of at least one semester in the University.

Duration

The minimum duration of part-time Ph.D. studies is 6 semesters (3 years). The maximum duration of the program cannot exceed 12 semesters (6 years). However, an extension of one year may be provided by the Director of the school on case by case basis.

1. Medical Insurance is compulsory for all Masters and Ph.D. Students. Premium for Medical Insurance may vary based on bulk rates negotiated by the University with service provider. Detailed information shall be shared in the offer letter
2. Please note that the Hostel Fees may increase yearly by 8% in subsequent years.
3. At the end of first year, students with less than 8 cGPA or students who do not wish to continue in the Integrated- PhD program shall be switched to MA/MSc track with applicable regulations including fee and assistantship structure for the second year. They shall receive MA/MSc degree after the completion of required credits.
4. Continuation of financial assistance is subject to satisfactory performance evaluated continuously, and compliance with all University regulations. The student is required to maintain a minimum CGPA of 7.00. Students with less than 7.00 cGPA at the end of first year shall lose their waivers and stipend.
5. The Financial Assistance is assured for a maximum of 60 months only and cannot be combined with any other fellowship or stipend.
6. All charges are payable at the beginning of the Academic Year as per schedule announced separately.
7. The use of laundry services from the University authorized vendor is mandatory for all students. Advances for Laundry are ₹ 2,100 per semester. These charges are subject to change and shall be communicated by Dean-Student Welfare.
8. Mess charges are on actuals and shall be paid directly to the vendor by the student.
9. Security deposit is refunded on Graduation after deduction of any recoveries.
