Admission to PhD program in Economics

The Department of Economics at the Shiv Nadar University would like to announce that admissions into the PhD program in Economics are now open for the 2018-19 academic year.

The first two semesters of the PhD program involve compulsory course work. After successfully completing the coursework, students are expected to work on their thesis. The department has a vibrant faculty with varied research interests offering the graduate students the option of working in a wide range of exciting fields. Please see the graduate prospectus of the department for more details.

Eligibility:

Minimum qualification for admission to the PhD programme is a Masters degree (in any discipline). The eligibility criteria mentioned above are minimum standards and applications not meeting the same will be summarily rejected.

The candidates will then be shortlisted for the final stage of the admission process on the basis of their academic record and research proposal.

Short-listed candidates will be required to demonstrate their knowledge through an on-site written test and an interview to be held at the university campus on July, 2018. Selections will be based on past academic performance, written examination and/or interview.

Please note that not all candidate meeting the minimum eligibility criteria may be shortlisted.

Admission Process:

1. Applications for admission are to be made online. The online application form can be found on the university webpage. The last day for applying to the program is **30th June, 2019**. The application fee is INR 1200.
2. Applicants are shortlisted on the basis of the application. **Please note that not all candidates meeting the minimum eligibility criteria may be shortlisted.**
3. Shortlisted candidates will be invited to the Shiv Nadar University campus for a written test on 8th July 2019, to be followed by an interview next day. Presence on campus for these two

days is mandatory. The university will provide accommodation for the candidates and also reimburse AC three tier train fare for outstation candidates.

Fees and Financial Assistance:

Detailed information about the fee structure and the nature of assistantships are available in the graduate prospectus.

All full time PhD students admitted into the program shall receive a fellowship consisting of **100% tuition fee waiver and 70% hostel fee waiver. The students shall receive a monthly stipend of ₹ 50,000 for first two years and of ₹ 55,000 for third and fourth year** subject to satisfactory performance in the program evaluated continuously, and compliance with all university regulations.

All interested applicant shall apply online from the link given below. Please follow the instructions carefully.

- Fill all the mandatory fields
- Online upload of following document is required
 - Passport size color photograph
 - Current CV
 - All Mark sheets/Degree Certificates (10th Standard onwards)
 - Standardized Examination certificate- CSIR, UGC, GATE etc. (only if applicable)
 - Statement of Purpose
- After online submission, print the completed form and send by speed post to the University at the address given below with following documents (Please add delete documents as per requirement.)
 - Completed form
 - Three reference letter in support of application
 - Demand Draft for application fee (If online fee payment mode is not used)

Please note that the application is not deemed complete until we receive all the necessary prescribed documents and application fees.
